Canadian Multi-Stakeholder Forum Selection Committee

Dear Colleagues/Collègues,

I am very excited about the formation of the Multi-stakeholder Forum and humbly submit my application to become a member to represent civil society in the ongoing dialogue about Canada's Third Biennial Plan to the Open Government Partnership (OGP). Open government is a personal passion of mine and core to rebooting and revitalizing modern democracy.

As an open data advocate, open data is not an end in itself. Open data is a foundation for open government to proceed; without open data and information, citizen engagement is not a balanced playing field and true collaboration between government and civil society is, at best, stifled and at its worst, ingenuine and patronizing. Canada's participation in the OGP is a major move toward institutionalizing open government in Canada and civil society must do its part to work with the Canadian government to make this commitment a success. I would be honoured to be a voice in this process.

As a New Brunswick native, I understand the Maritime perspective on the Canadian government. With over 15 years in Ontario and 6 years in Ottawa, I also have a solid understanding of the Ontario civil society experience and the forces and constraints experienced by those working in the federal government. During 2017 I have been on the Ontario Advisory Groups for the International Open Data Charter and Public Service Open Government Training.

I had the opportunity to attend the OGP Summit in Paris as one of Ontario's civil society representative. At the summit I had the honour of attending a breakfast hosted by Federal Minister Scott Brison and Ontario Minister Liz Sandals and had the opportunity to lead a discussion about the need for better open government coordination and collaboration. I also co-hosted a International Open Data Day event with the Treasury Board Secretariat of Canada. This past summer I represented Ontario civil society at the Subnational workshop in Washington D.C.

As the founder of the Open Data Institute node in Ottawa and an active participant in the last three Canadian Open Data Summits, I am well connected to the national open data movement. I am also a co-organizer of the Ottawa Civic Tech group and have had the opportunity to be involved in the emergence of a national civic tech community. These communities offer unique perspectives into the current Canadian civil society zeitgeist that I can leverage to broaden the voice of the forum.

Regardless of the outcome of this process, I will continue to provide a strong civil society voice for a collaborative and sustainable Canadian open government.
